All dancers currently in company for the 2016-17 season are required to take the intensive even if not auditioning. Attending the audition intensive does not guarantee placement in a MUL company. All decisions are final. ALL DANCERS ATTENDING MAKEUP AUDITIONS ARE STILL REQUIRED TO PAY THE SAME FEE. Upon completion of this form and payment, you will receive an interest form to complete via email.

All advanced dancers: \$325.00 includes audition fee

Petite company level: \$325.00 includes audition fee

Star Level dancers: \$325.00 includes audition fee (Intermediate level, less hours per week, email Melissa for details at mastersupperleveldance@gmail.com)

Mini company level: \$150.00 includes audition fee

All tuition and fees must be paid in full prior to attendance. Missed days from intensives cannot be made up and tuition is non-refundable.

WHAT TO BRING

Students should bring the following each day of the Intensive if they have a full day:

Bagged lunch, healthy snacks, bottled water/drink

Changes of dance clothes if needed, and any necessary personal items, toiletries and medications.

WHAT TO WEAR

All dancers should wear appropriate attire to the intensive and audition. Required dance attire is black leotard or black bra top and black booty shorts. Please pack all dance shoes (ballet, tap, jazz) and sweat pants if needed for floor work.
